ORDER-01/2019-GST

In exercise of the powers conferred by sub-section (2) of Section 4 of the Nagaland Goods and Services Tax Act, 2017 (4 of 2017) and in supersession to this Office Order-01/2018-GST dated 30th May, 2018, the Commissioner of State Taxes, Nagaland hereby orders that the following classes of Officers shall exercise the powers under Section 54 and 55 as the **territorial jurisdictional authority** as indicated in column (4) of the table given below with immediate effect:-
