

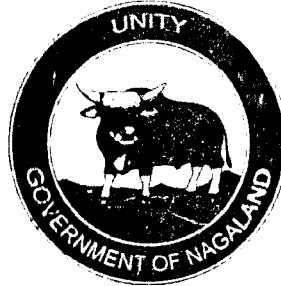

**NO.AGR/ESTT-93/96::** In exercise of the proviso to Article 309 of the constitution of India, the Governor of Nagaland is pleased to make the following rules for regulating the recruitment and other conditions of service of persons to the Nagaland Agricultural Services.

**1. Short Title & Commencement :**

- (a) These Rules shall be called the Nagaland Agricultural Services (Gazetted & Non-Gazetted) Rules, 2011.
- (b) They shall come into force with immediate effect on the date of its Notification.
2. This has the approval of the Cabinet conveyed vide their O.M NO.CAB-2/2008 (Pt) dated 09-09-2011.
3. The Nagaland Agricultural Service Rules, 1976 with its amendments is hereby repealed.
