NOTIFICATION

Dated 30 September 2015

**No. FIN/REV-3/27/02:** In exercise of the powers conferred by sub-section (3) of Section 6 of the Nagaland Entry Tax Act, 2013, the Governor is pleased to allow exemption of 'entry tax' on the import into Nagaland of 5,000 (five thousand) sq. ft. of 'marble stones' and 1254 (one thousand two hundred and fifty four) running feet of 'ceramic tiles' by M/S Janjati Shiksha Samiti, Nagaland, for construction of Infants Digital Home at Kevijau Village, Dimapur, Nagaland.

2. The above exemption is granted subject to the following terms and conditions listed below:-
- (i) The exemption shall remain valid for a period of 6 (six) months from the date of publication of this notification in the official gazette.
  - (ii) This exemption is granted subject to the condition that the above items have been donated free of cost. M/S Janjati Shiksha Samiti, Nagaland, shall accordingly furnish proof of free will donation of the above items from the donors to the Commissioner of Taxes, and shall also intimate in advance to the Commissioner of Taxes the likely date of import of these goods into Nagaland for examination and verification.
  - (iii) The above goods shall be imported under the cover of prescribed documents under the Nagaland Entry Tax Act and Rules, and fulfillment of all prescribed formalities.
  - (iii) M/S Janjati Shiksha Samiti, Nagaland, shall also furnish to the Commissioner of Taxes proof of final and complete utilization of the above goods at the site of construction.
3. In the event of default of the above terms and conditions, the exemption shall be rendered invalid, and M/S Janjati Shiksha Samiti, Nagaland, shall be liable to pay the full amount of Entry Tax as applicable.
