NOTIFICATION

In exercise of the power conferred by the provisions of Section 3 of the Nagaland (Ownership and Transfer of land and its Resources) Act, 1990 (Act 1 of 1993) and Chapter-II of Rule 7 of the Nagaland Coal Mining Policy & Rules (First Amendment) 2014, and in pursuance of the Government approval letter vide No. GM-21/COAL/98/2010/273, dated 26th November, 2020, the State Govt. hereby grant Coal Mining Lease (CML) to **Shri. Naoman Konyak**, bearing Registration No. **CML -02/21** for an area measuring 4.0 (two hactares at Oting Village, Naginimora Sub-Division, District Mon, Nagaland for a period of **2 (two)** years w.e.f the date of issue of this Notification.

This Coal Mining Lease (CML) for operating mini opencast mining is granted under the following terms and conditions, that the CML holder shall :-

1. strictly abide by the provisions of the Nagaland (Ownership and Transfer of Land and its Resources Act, 1990, the Nagaland Coal Policy and Rules (First Amendment) 2014 and the Mining Lease Agreement;
2. have the right to undertake all prospecting and mining activities in the leasehold area;
3. intimate the DGM and the authorized District-in-charge if coal deposit/seams are encountered, which shall required detail drilling/prospecting of the area;
4. intimate the DGM and the authorized District-in-charge about the date of commencement of mining works;
5. intimate the DGM and authorized District-in-charge about abandonment, surrender of prospecting or mining operation;
6. intimate the DGM and the authorized District-in-charge about accidents occur during prospecting/mining operation;
7. regularly inform about certain appointment, resignation, termination and change of address;
8. be responsible for the compliance of the provisions of rules pertains to Environment and shall strictly implement the Eco-friendly Mining Plan (Land, Air, Water & Noise Management Plan) as submitted and duly approved by the Govt.;
9. be responsible for back filling and afforestation of the mined out area and compliance of the provisions of rules pertains to environment;

10. be responsible to make such provisions for the health and safety of the persons employed in connection with prospecting or mining operations;
11. be responsible for crop or environmental damage caused as a result of mining operations;
12. the State Govt. shall have the right to requisition any amount of coal from the Licensee for its consumption and that the Licensee shall make available to the State Govt. such quantity of coal as and when requisitioned;
13. failing to comply with any of the above stated conditions shall lead to cancellation of the License;
14. the concerned District-in-charge is empowered to monitor and regulate the mine and to issue notices for stoppage/closing of mine and recommend for cancellation of the CML (SPD) in the event of violation of rules and standing orders of the Govt.


